### REACH DECLARATION

This declaration is issued by Ley Rubber Ltd to provide customers with a statement on our position with respect to REACH UK directive.

The EU REACH regulation ("Regulation (EC) No. 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals") has been brought into UK law under the European Union (Withdrawal) Act 2018. REACH, and related legislation, has been replicated in the UK with the necessary changes to make it operable in a domestic context. The key principles of the EU REACH Regulation have been retained and referred to as UK REACH including EU REACH Annex XVII. This will be aligned to but operate independently from EU REACH, however, under the Northern Ireland Protocol the EU REACH Regulation continues to apply to Northern Ireland.

Ley Rubber Ltd is not a manufacturer of substances as defined in the REACH UK directive and therefore has no responsibilities for registration.

Ley Rubber Ltd does not expect to have to register any substances itself on the grounds of particular or confidential usage.

Ley Rubber Ltd is classed as a Downstream User and will comply with its obligations under the REACH UK directive within this definition. As a result, we are in close contact with all our suppliers regarding their plans to register/pre-register our raw materials.

I can confirm that these compounds do not contain any "substances of very high concern" (SVHC's) and any REACH EU XVII substances as referred above, and as such are currently classed as EU and therefore UK REACH compliant. Please note that new substances may be added to the REACH lists every year. This grade also complies with the substance restriction requirements of RoHS Directive EU 2015/863 (commonly known as RoHS 3). The process of replication to UK RoHS is currently underway, and initially is expected to feature the same list of substances as EU RoHS 3.
